

Total encounters at the U.S.-Mexico border at and between ports of entry (January 2024 - July 2025)

















## Train people about their constitutional rights

- 3. Accurately count migrant deaths, with the goal of ending more deaths at our borders



## History of Sensitive Locations/Protected Areas

- 2011- Immigration and Customs Enforcement (ICE) Director Morton issues policy on preventing enforcement in "sensitive locations" (houses of worship, schools and hospitals) absent exigent circumstances
- 2014- U.S. Customs and Border Protection (CBP) issues a similar policy for 100 mile border zone
- 2021- Biden Administration issues a DHS-wide policy and broadens the locations that apply; renames it "Protected Areas"
- 2025-Trump Administration rescinds Protected Areas policy and issues general guidelines without any specifics on conduct for enforcement in such areas

## Safe Spaces and Key Elements of SAFE SPACE POLICY

- Which staff members are authorized to speak with an agent of authority (e.g., a police officer, licensing representative, etc.)
- Collecting, storing, and releasing private information about parents, children, and staff
- Communicating urgent information to staff and parents
- How authorized staff and parents are able to access the facility
- Expectations for visitors
- Which areas to explicitly mark as "private"
- Establishing emergency contacts

#### What's Next? What Can YOU Do?

- **SAFE SPACE POLICY** -If you don't have a space Spaces policy- consider drafting one. Or reviewing and updating existing document.
- **ACCOMPANY and DOCUMENT** Accompany individuals to houses of worship, hospitals, clinics, schools, food pantries and document if and when incidences occur.
- <u>JOIN</u>- Join the CLASP Protected Areas Working Group.
- <u>ADVOCATE at NATIONAL LEVEL-</u> Urge lawmakers to sign Protecting Sensitive Locations Act in Senate S.455 and the House HR 1061
- **ADVOCATE at STATE LEVEL**-Consider engaging state leaders to enact protected areas/sensitive locations legislation at the state and local level.

### Funding for Enforcement: H.R. 1 and Impacts

- Provides \$170.7 billion in additional funding for immigration enforcement-related activities to the Department of Homeland Security (DHS) and its sub-agencies, Immigration and Customs Enforcement (ICE) and Customs and Border Protection (CBP) as well as for the Department of Defense (DOD) for activities related to the military's presence along parts of the southern border.
- The biggest element of immigration-enforcement related funding in H.R. 1 is \$75 billion to ICE over four years, (roughly \$18.5 billion/year) to arrest, detain, and deport immigrants.
- This funding will create a large expansion in the number of immigrant detention facilities nationally as well as a goal of an increase of over 10,000 ICE officers.
- A recent CBO report estimates that H.R. 1 will result in the removal and voluntary out-migration of more than 300,000 immigrants between 2026 and 2030 <a href="https://www.cbo.gov/system/files/2025-09/61390-demographic-update.pdf">https://www.cbo.gov/system/files/2025-09/61390-demographic-update.pdf</a>

#### What Does This Funding Mean? What Can You Do?

- <u>Family Impacts</u>: An estimated 18.4 million children under age 18–or about 1 in 4 children nationwide have one or more parents who were born outside of the U.S.; among them, 6.3 million live in households where neither parent is a U.S. citizen.
- <u>Multi-Generational Enforcement</u>: Detention facilities and levels of detention that have not been witnessed in the United States.
- Costs to U.S. Taxpayers: Over \$170 billion dollars- (This is 2.5X the cost of ENTIRE DHS budget in 2024.)
- WHAT CAN YOU DO: Demand oversight from Congress. Demand accountability on how that money is spent and what it looks like.

## Family Separation 2.0: More Complex Just As Harmful

- No known policy documents at this time; No "Zero Tolerance" Memo
- Not at the border -- in the U.S. interior
- Parents removed without their children or access to their children/planning while they are in detention
- Can be related to a child's Unaccompanied Children (UC) status

#### **Brief Refresher on H.R.1**

- H.R.1 is a generational threat to families. This law:
  - Expands the federal government's detention and mass deportation apparatus.
  - Raises the cost of maintaining lawful status and it
  - Eliminates access to vital services for refugees, asylum seekers and certain other immigrants with lawful status.
- Honoring Ayman, Xotchil, Ximena, Marcelo, Narciso, Yeon-soo...



### **Appropriations Opportunities**

- The accounts that are most central are Homeland Security (HS), Labor-Health and Human Services (LHHS-ED), Commerce, Justice, and Science (CJS), and State and Foreign Operations (SFOPS).
- Use our upcoming ACTION ALERT to urge your Senator and House Representatives to:
  - Significantly reduce funding for extreme enforcement and detention contracts and include basic guardrails protecting the most vulnerable in custody, including children.
  - o Include essential and historically bipartisan legal orientation programs, which help ensure that people in deportation proceedings can exercise their due process rights.
  - Restore investments in refugee processing and resettlement, cementing the U.S. as a welcoming country for those fleeing persecution.
